Terms of Release - Responsibilities of operator

- 1. Inoperable Equipment: The Renter is responsible to inspect and notify the Union SWCD if any part of the equipment is broken, defective, or otherwise inoperable before use, in transit, during operation, and when equipment is returned.
- 2. Waiver: Renter waives any and all claims for personal injury, loss of time, and property damage arising from the use of the equipment.

- 3. Time of Return: The base rental rate is for a period of 5 regular week days. The Renter is responsible for timely return of the drill, as the equipment schedule is based an agreed timeline for the next Renter. If for any reason the Renter would like to extend rental time beyond 5 days, the Union SWCD must be notified at least 1 day prior to the scheduled return date and the extension must be approved based on scheduled availability.
- **4. Prohibited Uses:** Use of equipment beyond agreed upon application (place of use, time of use) constitutes a breach of contract and requires immediate return of equipment and possible forfeiture of deposit. Forfeiture of deposit will be based on wear and or damage to equipment.
- 5. Return of Dirty and/or Damaged Equipment: Return of equipment that is damaged or dirty will result in forfeiture of deposit. Equipment should be rinsed down and weed free, and seed boxes should be free of seeds or debris. Equipment will be inspected by Union SWCD staff at the time of return and assessed for damage and cleanliness.
